SUMMARY OF RULES

- Competition is open to students of orchestral instruments only
- Competition is open to students residing in the following communities:
Rockport, Gloucester, Manchester-by-the-Sea, Beverly, Essex, Ipswich, Topsfield, Rowley, Newburyport, Hamilton/Wenham, Salem & Marblehead, OR currently studying with a member of the Cape Ann Symphony.
- Students must be enrolled in grades 6-12 as of September 30, 2019
- Applicants must submit application, application fee and video no later than September 30, 2019
- Live/final audition will be held on October 12, 2019 from 10-12. Location TBD
- Musical selection must be the same in video submission, live round (if chosen) and final public performance with the CAS (if chosen)
- Student must provide his/her own accompanist for the live/final round of competition
- Student must play musical selection from memory for live/final round
- Musical selection must be available in the public domain (<https://imslp.org/>) for both orchestra & soloist and should be no longer than 8 minutes. May be cut to shorten length.
- The Music Director and the Competition Committee reserve the right to choose no winner based on performances of applicants
- Winner must be available for all rehearsals as requested by Music Director Yoichi Udagawa
- Winner must be available to perform with the Cape Ann Symphony on November 30th, 2019 during the Holiday Pops concert at 7:30pm in Manchester, MA
